



TERMS OF CONDITIONS FOR PCC ICO

PCC Coin (hereinafter referred to as 'PCC') Initial Coin Offering (ICO) of PCC tokens on our website i.e. www.pccico.com.

The following terminology applies to these Terms and Conditions of Use (our “Terms”), the Privacy and Transparency Statement, and any and all other agreements between you and us:

“Client,” or “Customer,” or “User,” or “You,” or “Your” refer to the person accessing our website i.e. www.pccico.com, and accepting our Terms.

"We", or "Our", or "Ourselves", or "Us" or “pccico.com,” or “www.pccico.com,” refer to the internet website pccico.com, and to its owners, operators, employees, officers, agents, insurers, suppliers, and attorneys.

“Party” refers to either you or us.

In these Terms, unless the context otherwise provide, words indicating the singular shall be understood to include the plural and vice versa and words indicating gender include all genders.

“Digital asset,” “asset,” “coin,” “digital currency,” “good,” “ledger entry,” and “token” refer to blockchain-based software ledger data entries.

As set forth below, you further represent and warrant that, to the extent permitted by law, you are authorized to purchase PCC Tokens in your relevant jurisdiction, are of a legal age to be bound by these Terms, and will not hold liable for any losses or any special, incidental, or consequential damages arising out of, or in any way connected to the sale of PCC Tokens, now or in the future, PCC and its affiliates, and the officers, directors, agents, joint ventures, employees and suppliers of PCC or its affiliates.

2. Terms

5. ICO Duration

5.1 The ICO Period starts on September 20, 2017 and ends November 20, 2017.

5.2 The coins or tokens which are not sold during the entire Pre-ICO and ICO and not distributed according to ICO conditions, will be cancelled and destroyed (burned) at the end of ICO i.e. after November 20, 2017.

5.3 We reserve the right to change the start date of the ICO as well as the right to extend the sale duration for any reason, including, failure to complete the sale of PCC tokens designated for offer, the unavailability of the pccico.com ICO website, or other unforeseen security or procedural issues.

5.4 The time terms mentioned in 3.1 above can be reviewed by the owners and Information will be provided at the pccico.com web site in such cases.

6. Number of Coins and Valuation of PCC Token

We plan to sell 1,000 Million PCC coins issued during the ICO. The price of the PCC coin is fixed at ETH 0.0002.

7. ICO Portal

The ICO will be conducted through our website www.pccico.com and users will have to send Ethereum (ETH) from an Ethereum Wallet to PCC Coin crowd sale Ethereum Smart Contract address:

8. How to Invest

8.1 Investors can subscribe to the ICO and purchase tokens through www.pccico.com.

8.2 Tokens can be purchased using Ethereum(ETH) or Bitcoin(BTC).

9. ICO Coin Distribution of PCC tokens

9.1 All PCC digital tokens purchased or received during the ICO will be distributed forthwith and immediately on confirmation.

9.2 The amount of coins that are created for the PCC chain are all dependent on how many coins are subscribed during the ICO. The Management team owns and holds 25%, partners and advisors holds 10%, and 5% is reserved.

9.3 As we cannot determine the total PCC coins that will be subscribed, the ICO operates based on percentages to ensure fairness for all. The ICO percentages are as follows.

- 40% of the amount received through ICO will be used to develop the products.

- 10% of the amount received through ICO will be used for operational expense.
- 10% of the amount received through ICO will be used for equipment and infrastructure.
- 15% of the amount received through ICO will be used for marketing, advertising, and promotion.
- 10% of the amount received through ICO will be used for business development and content production.
- 5% of the amount received through ICO will be used for legal, compliance, and regulatory.
- 5% of the amount received through ICO will be used for customer support.
- 5% of the amount received through ICO will be used for Exclusive good production.

10. Listing of PCC Coins or Tokens

After the completion of ICO, the coins shall be listed on multiple cryptocurrency exchanges.

11. Prices, Exchange Rates, and Confirmations

Digital currency and digital assets are highly experimental and risky. We regard digital currency payments as “accepted” when one block confirmation has been registered.

12. Refund Policy

Digital currencies, tokens, and digital assets are, by their nature, generally irreversible, and their exchange rates are highly volatile and transitory. For these reasons, customers may not receive refunds for confirmed transactions.
